From the Legal and Compliance category: **Attorney-client Privilege Required, External Outbound**

Detects the absence of a required privilege label or reference to a privileged project. Once identified, prompts the sender to include a label or to drag-and-drop a label presented in the alert.

Sarbanes-Oxley
Addresses the legal requirements under SOX and the whistle-blower protections afforded to employees.

From the Information Security category: **Information Boundary Policy Group**

Provides the controls needed to ensure communication compliance that training alone cannot.

From the Human Resources category: **Offensive Content Control Policy Group**

Ensures an environment free of inappropriate messages and brings unwanted activity to the attention of a supervisor, HR officer or legal counsel.

PolicyPak categories include:

- **Legal and Compliance**
